The terms of reference for the members of the Task Force for the "Safety of Women in the Campus" are as under:

1. The members of the Task Force will assess the academic and administrative activities pertaining to "Safety of Women" in the University Campus.
2. The members of the Task Force will undertake different activities which may ensure better atmosphere at work place for the women (staff and student).
3. The members of the Task Force will suggest remedial measures to the Competent Authority to provide facilities and infrastructure to ensure "Safety of Women" in the University Campus.
4. The members of the Task Force will hold the meeting with the stakeholders time to time and invite suggestions for better environment and "Safety of Women".
5. The members of the Task Force will convene at least once in every two months and may also involve the officers of the following committee members:
 - i) Chairman Classroom committee
 - ii) Members of the Staff Council
 - iii) Members of the Student Council
 - iv) Members of the Staff Grievance Committee
6. The members of the Task Force will attend all the grievances related to women safety and sit together to resolve the issue with immediate action and disciplinary action, any, will be taken as per University rules and regulations by the concerned branch, after approval by the Competent Authority.
7. The members of the Task Force will organize programmes to sensitize the women (staff and students) about their safety by inviting outside agencies.

The Tenure of the committee is for a period of one year.
