As far as disabled friendly facilities available at University Facilitation Centre in the context of the initiatives undertaken these days for NAAC re - accreditation of the University, the submission of the department is as under -

- University Information Centre is a nodal point for all types of 1. information dissemination for applicants, potential applicants. students, staff, alumni & other stakeholders. The staff deployed at the Centre tries their level best for the purpose, even dissemination information to disabled persons visiting
- 2. There is disabled friendly pathway leading to the Centre. Our security guards help them to reach all the way to the Centre for such disabled information seekers. There is a dedicated disabled friendly information counter for such persons.
- 3. There is a separate disabled friendly washroom for such persons in the Centre.
- 4. Our general counsellors deployed at the Centre tender all support such disabled persons. In case of visual impared, our counsellors provide all the asked information verbally. In case of information seeker, our counsellors provide all the asked information verbally or in writtren or photocopied formats.
- 5. In case of deaf information seekers, our counsellors provide information in written or photocopied formats.
- 6. There is a need of counsellor at the Centre having ample experience of communicating in sign languages for deaf & dumb information seekers. A file in this regard is already in process to extend that particular disabled friendly facility also at the University Information Centre.

NOTIFICATION

For Person with Disabilities (Equal Opportunities Protection of Rights and full Participation) Act.

A. For persons with disability of 40% or more

- The candidate shall have the discretion of opting for his own scribe/reader/lab. Assistant or apply to the Examinations Division for the same with the approval of the Controller of Examinations.
- In case, the scribe/writer is arranged by the candidate, the candidate will bear the cost of b) arrangement at their own. The candidate shall be responsible for any mis-conduct on the part of the scribe/writer brought by him/her.
- In case, the scribe is arranged by the Examination Division, the payment will be as per
- Compensatory time of 60 minutes @ 20 minutes per hours may also be given to permanent disabled persons for End Term Exam./Written Test of 3 hours duration and alternatively 40 minutes for 2 hours duration exam and 20 minutes for 1 hour exam. /Entrance Test.
- No extra fee will be charged from the candidate, as per Provision of the Act. e)
- Extra arrangement should be done at the Examination Centres by the Centre Superintendent for which one extra invigilator should be provided in a separate room and payment may be made as per approval rates of the University.

B. For temporary injuries / accident cases

In this case writer subject to the approval of the Controller of Examinations will be provided by the University or Centre Superintendent under the written prior approval of the Controller of Examinations with all medically supported documents and Rs. 1000/- per paper should be deposited in the University by Demand Draft in Favour of Registrar, GGSIP University, by the candidate. Extra time may be provided @ 20 minutes per hour of examinations, if approved, by the Controller of Examinations.

- Separate room will be provided, if necessary.
- Extra Invigilator and Attendant will be deputed and paid as per approved rates by the University.
- Writer will be paid as per norms.
