Schedule for First Round of Counselling in Post Graduate Ayurveda Courses (PGAC) i.e. MD/MS Ayurveda Courses, CET Code Code 196: Academic Session 2018-19

- 1. This is in continuation to University's notification No. GGSIPU/Admissions/2018/5642 dated 20.09.18, titled, "Schedule for 'Mandatory Registration and Preparation of Merit List' and 'Correction in the CET Details' for Admission in Post Graduate Ayurveda Courses (PGAC) i.e. MD/MS Ayurveda Courses, CET Code Code 196: Academic Session 2018-19".
- 2. Consequent upon the Registration for Counselling and verification of documents, the Schedule for First Round of counselling in PGAC is as follows.
- 3. It may please be noted that the candidates who had not registered for counselling on the University's notified dates, are not eligible to participate in the counseling.
- 4. Tentative merit lists is attached herewith. The final merit shall be ascertained at the time of admission / counselling. The final seat matrix shall be displayed at the time of counselling.
- 5. The candidates who had registered on the notified dates and have completed their BAMS from the GGSIPU, shall be deemed to be registered in both the lists i.e. (i) 'GGSIP University Quota' and (ii) 'All India Quota' as well as mentioned in the University Notification No. 5642 dated 20.09.2018. However, the same shall be done purely on merit and on the roster point.
- 6. Roster Point: A separate roster shall be followed for admission on 'GGSIPU seats' and 'All India Seats'. The roster shall be continued from the next roster point, where the counselling was closed in the Academic Session 2017-18 GGSIPU Quota Roster Point shall start from 16 during academic session 2018-19.. For All India Quota, the 200 Point Roster shall start from 44 during academic session 2018-19.
- 7. Internship. As notified by Ministry of AYUSH vide their letter no. R-11011/02(2018-EP(IM-1) Part-I dated 21.09.2018, the "cut-off date for completion of internship will be 31st October 2018 which is a requirement for admission in PG Courses of academic year 2018-19".
- 8. Qualifying Marks. As also mentioned in the University's Notification No. 5642 dated 20.09.2018 and also detailed in the letter of Ministry of AYUSH vide their letter no. R-11011/02(2018-EP(IM-1) Part-I dated 21.09.2018, the minimum eligibility marks as per Clause 8(5) of Post Graduate Ayurveda Education Regulation is as below:-

"The minimum eligibility marks of the entrance test for admission in the case of general candidates shall be fifty percent of the total marks, in the case of candidates belonging to the Scheduled Castes, the Schedule Tribes and regular Central or State Government service candidate shall be forty percent. And in the case of candidates of candidates belonging to the Other Backward classes shall be forty five percent."

- 12. Since the roster point can not be left blank, the conversion of seat of a category will be during the first counselling itself.
- 13. Candidates who are already admitted to any Post Graduate Medical Degree / Diploma course in any University / Institution as on date of counselling (i.e. already pursuing) will not be eligible for admission.
- 14. Withdrawal of Admission and Refund of Fee. The allotted candidates may withdraw their admission upto 4.00 PM on 26.10.2017. Such candidates shall visit the Admissions Branch, GGSIP University, Sector 16C, Dwarka, New Delhi alongwith their original admission slip alongwith the prescribed format (Appendix 8 Form for Withdrawal of Admission available in Part B, Admission Brochure 2017-18).

All the refund applications shall be processed in accordance with the Refund Policy 2018-19.

All the admitted candidates are required to report same day or next working day in the allotted college.
