Admissions in Management Quota

AS notified Vide No. GGSIPU/JR (Admissions)/MQ/2017-18/22019 dated 12/07/2017, filling up Management Quota Seats in Unaided Institutions for the Academic Session 2017-18 and details of same as also mentioned in Part A of the Admission Brochure, for Academic Session 2017-18. The following provisos are reiterated here for information of all candidates and stakeholders:


Refer Clause 9.4.10 of Part A, Admission Brochure for Academic Session 2017-18 (pg 69-70), '***A candidate, who has taken admission through online / offline counselling or in the Spot / Open House Counselling, shall not be eligible for admission in Management Quota Seats.***'

Also Refer Clause 9.3.1.10 of Part A, Admission Brochure for Academic Session 2017-18, (pg 69) states that '***....candidates once enrolled in the University at the end of counselling will not be considered for admission through Management Quota.***'

As detailed above for provisions mentioned in the Admission Brochure for Academic Session 2017-18, it is reiterated that a candidate who had taken admission through online / offline counselling and have reported; and are admitted and/or admission taken in the Spot / Open House counselling, shall not be eligible for admission in the Management Quota seats. It is implied that that the candidates with 'Admitted' status shall not be eligible for admission in the Management Quota seats.

All CET qualified candidates taking admissions under Management Quota and all Unaided Institutions (except Minority Institutions/unaided Institutions who have surrendered Management Quota) for the Academic Session 2017-18, may again take note of the details as above and such Unaided Institutions will be required to submit the list of admitted candidates under Management Quota following meticulously the prescribed procedures as detailed in notice GGSIPU/JR (Admissions)/MQ/2017-18/22019, dated 12/7/2017.


