PROCEDURE FOR FILLING UP OF VACANT SEATS AFTER CONDUCT OF OFFLINE COUNSELLING (SPOT/OPEN HOUSE COUNSELLING) FOR VARIOUS PROGRAMMES DURING THE ACADEMIC SESSION 2017-18

The University conducted Offline Counselling for admissions to various programmes in the Academic Session 2017-18. Vacancies after these rounds of counselling were taken to SPOT/OPEN Counselling, where-so-ever as applicable. Certain seats which could not be filled even after conduct of SPOT/OPEN Round, the procedure for filling up those unfilled seats in is given in the succeeding paras.

The dates, by which, activities for filling up of seats through Direct Admission is to be completed, is stated as below:-

Date	Activity to be done
21.08.2017 (Monday)	Constitution of Admission Committee at respective colleges comprising of Director/Chairman-person, two faculty from the institute. The institute shall request for the appointment of the University Observer.
22.08.2017 (Tuesday)	Newspaper Advertisement by Affiliated Institutes / Colleges regarding filling up of vacant seats, if number of vacant seats are more than Fifty (50) or by uploading on Institute's website if the vacant seats are less than or equal to fifty (50).
23.08.2017 (Wednesday) to 25.08.2017 (Friday) (Till 05.00 PM)	The eligible candidates shall apply in the respective Affiliated Institutes/Colleges
26.08.2017 (Saturday)	Merit List to be displayed by Affiliated Institutes/Colleges on their website and notice boards
28.08.2017 (Monday)	Counselling to be done at respective Affiliated Institutes/Colleges from the merit list for provisional allotment
29.08.2017 (Tuesday)	Files of admitted candidates to be submitted in GGSIP University for verification and admission processing between 10.00am to 4.00 pm



(CET Code 100) and B.Ed (Special Education)(CET Code159), the vacancies in institution/colleges shall be filled from the list of not-admitted CET's Qualified Candidates of the respective programme and as notified and conducted by the University. In B.Arch.(CET Code 100) and B.Ed (Special Education)(CET Code159),
3. Tentative Vacancies Position as on 24th August, 2017 taking into account applications of withdrawals of admissions submitted in the Admissions Reception Counter GGSIPU is annexed.
4. The Vacancy Position may change daily as the applications of withdrawals of admissions as submitted in Admissions Reception Counter, GGSIPU are Processed (on the next day basis).



5. Applications for withdrawals of admissions received till 24th August, 2017 shall be included in the final Vacancy Position for Consideration of admissions as notified above.
