**Important Notification Regarding Admission To Post Graduate Medical Courses vis-à-vis Re-inviting Online Applications Consequent To The Revised 'Percentile' and 'Cut Off Score' Issued by National Board of Examinations Consequent To The Notification By Ministry of Health & Family Welfare**

1. Ministry of Health & Family Welfare vide its Notification dated 24/05/2017 has conveyed that it has been decided in consultation with Medical Council of India to reduce the percentile cut offs for NEET PG 2017 by 7.5 percentile, taking them to 42.5 percentile for general candidates and 32.5 percentile for reserved category candidates.
2. Further, National Board of Examination, on 25/05/2017 has notified the 'Revised Qualifying Percentile' and 'Revised Cut-Off Score' on their website.
3. In view of this, the University re-invites online applications, on its website [www.ipu.ac.in](http://www.ipu.ac.in) for registration for admission in Post Graduate Medical Courses (MD/MS/Diploma courses) in its affiliated medical colleges. The last time and date for inviting such applications is upto 4.00 PM on 28/05/2017.
4. The candidates who were NEET PG 2017 qualified as per the 'Percentile' and 'Cut-Off Score' as notified by NBE on 13/01/2017 but could not apply online are also eligible to apply within the notified date and time as mentioned above.
5. Only the candidates, who have passed MBBS from the affiliated medical colleges of Guru Gobind Singh Indraprastha University and must have completed one year compulsory rotatory internship on or before 30<sup>th</sup> April 2017, are eligible to apply.
6. The Mop-Up round of counselling shall be held on or before 31<sup>st</sup> May 2017 as per the schedule laid down by Hon'ble Supreme Court of India. The University follows a 200 point roster system for allocation of seats. The starting point for counselling for admissions, during Mop-Up, shall be 137 (UR).
7. All the seats, which remained vacant, after completion of 2<sup>nd</sup> Counselling shall be offered during the Mop-Up Counselling. Also, any other vacancy, if exists, due to non-joining within the stipulated date (so conveyed by the medical college), or otherwise, shall also be added as a vacancy during Mop-Up Counselling.
8. All the candidates shall be called in the order of merit, roster-point wise, in their respective categories starting from Roster Point 137 (UR). All the candidates shall be allowed to participate in the Mop-Up Counselling, irrespective of the fact that candidate was admitted, so far, or not. It will include withdrawal, reported/not reported). During the process, any seat vacated by a particular candidate, shall be offered to the candidates coming on to the next roster point alongwith the other vacant seats available to him/her at his/her turn. However, such candidates shall not have any claim on the seats already allotted during 1<sup>st</sup> and 2<sup>nd</sup> Round of Counselling.

9. 'Registration for Counselling and Verification of Documents', for the candidates who have applied earlier but could not come for "Registration for Counselling and Verification of Documents" on 14/04/17 or have applied afresh between 27/05/17 & 28/05/17) shall be carried out on 30/05/17. The detailed counselling schedule, for Mop-Up counselling shall be displayed on the University website on 29/05/2017.

10. All the perspective candidates are requested to refer to the Admission Brochure 2017-18, Schedule of 1<sup>st</sup> and 2<sup>nd</sup> Counselling & other notifications issued with respect to PGMC and keep their 'documents required at the time of counselling' and 'fee to be paid at the time of counselling' ready.
