**Schedule of 2<sup>nd</sup> Round of Counselling for PGMC in respect of Hamdard Institute of Medical Sciences and Research (HIMSR) Jamia Hamdard held under the supervision of the Department of Health & Family Welfare, Govt of NCT of Delhi – to be conducted by Guru Gobind Singh Indraprastha University**

This is in continuation to University's notification, No. GGSIPU/Admissions/ 2017/ 20570 dated 13/05/2017 regarding Schedule for 2<sup>nd</sup> Round of Common Counselling for post graduate medical courses.

**IMPORANT NOTE**

Hamdard Institute of Medical Sciences and Research (HIMSR) Jamia Hamdard

Hamdard Institute of Medical Sciences and Research (HIMSR) Jamia Hamdard did not participate in the 1<sup>st</sup> Round of Counselling for admission which was held on 14<sup>th</sup> April and 15<sup>th</sup> April 2017. Counselling for admission in PG Seats in HIMSR Jamia Hamdard shall be held during the 2<sup>nd</sup> Round of Counselling. All the stake holders are requested to visit their website as well for details and further updates.

1. GGSIP University shall carry out admissions on the following PGMC seats of HIMSR Jamia Hamdard :-

2. Admissions will first be made against the Muslim Minority Seats and if any seat remains vacant in the Minority seat, the same shall be treated as 'open' and filled up on merit.

3. Fee to be paid at the time of Counselling

A candidate, who is allotted a seat, will be required to pay Rs.26,000/- (i.e. Rs.25,000/- and Rs.1,000/- NON-REFUNDABLE Counselling Participation Fee) on the spot, at the time of counselling. The fee will have to be paid in the form of Demand Draft in favour of "Registrar, Guru Gobind Singh Indraprastha University" payable at Delhi. Balance fee, if any shall be paid, directly in the allotted college after admission.

4. HIMSR Jamia Hamdard have displayed the merit list prepared on the basis of NEET PG 2017 on their website on 16<sup>th</sup> May 2017. Further, they have also displayed the fees payable in HIMSR after admission, documents required at the time of counselling, Surety Bond conditions etc on their website.

5. 'Registration for Counselling and Verification of Documents'

(a) All the candidates who have applied in HIMSR within the stipulated date and also qualified NEET PG 2017 are eligible for 'Registration for Counselling and Verification of Documents'.

(b) All the NEET qualified candidates will present themselves for 'Registration for Counselling and Verification of Documents', on the scheduled date and time, as given below :-

(c) This 'Registration for Counselling and Verification of Documents' will be valid for 2<sup>nd</sup> round of counselling and any subsequent counselling, if carried out, during the Academic Session 2017-18. In no case, a candidate will be allowed to participate in unless he/she has registered for participation in the counselling.

(e) At the time of 'Registration for Counselling and Verification of Documents', the candidates shall produce the set of photocopies of documents alongwith the original documents.



6. The last date for joining the allotted candidates, in respect of the candidates taking admission is 27<sup>th</sup> May as per the time lines stipulated by the Hon'ble Supreme Court of India.


7. **All the admissions are provisional. The candidates shall undergo biometric verification to be carried at the respective allotted medical colleges.**
