**Schedule of Mop Up Counselling / Admission for BDS (2018-19)**

**Conduct of Counselling for admission in BDS programme in the affiliated Dental College with Guru Gobind Singh Indraprastha University, New Delhi**

**Venue of Counselling: Guru Gobind Singh Indraprastha University,  
Sector 16 C, Dwarka, New Delhi-110078.  
(Nearest Metro Station – Dwarka Sector 14)**

**The Candidate must read the schedule carefully.**

**----→ ADMISSIONS WILL BE MADE ON "NEET ALL INDIA RANK" PURELY ON MERIT as per the qualifying percentile of NEET UG 2018.**

**----→ "NEET ALL INDIA RANK" shall be referred to as 'Rank' further in this schedule.**

1. This has reference to the University's Notification No. GGSIPU/Counselling Schedule-BDS/Admissions/2018/3665 dated 01.07.2018, regarding Schedule of 1<sup>st</sup> Round of Counselling and 4679 dated 08.08.2018 regarding Schedule of 2<sup>nd</sup> Round of Counselling.
2. This has reference to the Revised Time Schedule displayed on the website of MCC/DGHS dated 03.08.2018 vide which Mop-up Counselling (State Counselling) is to be carried out between 19<sup>th</sup> August 2018 and 22<sup>nd</sup> August 2018.
3. The University shall carry out admissions of "Delhi Candidates" i.e. the candidates who have completed their qualifying examination (11<sup>th</sup> and 12<sup>th</sup>) from any school located in NCT of DELHI ONLY.
4. **For Eligibility, Documents are required at the time of counselling, Fees, Age Bar, Age Relaxation please refer to the above mentioned notifications / schedules and Admission Brochure 2018 of GGSIPU.** As mentioned on in point no. 11, page 11, Part-A, Admission Brochure 2018-19, in the event of any provision mentioned in the Admission Brochure being found to be at variance with any binding regulation / directions of any statutory body i.e. Medical Council of India, Dental Council of India etc, then the higher norms will prevail.
5. The Mop-Up Counseling will commence from 'NEET ALL INDIA RANK' 01 onwards for all categories and the seats will be allotted strictly on the basis of merit. The candidates who were absent in the first counselling and second counselling will also be permitted to attend the second counselling.  
Admission will be made strictly on merit basis and the counselling / admissions will stop when all the seats get filled up.

All the candidates have been called to ensure that no seat remains vacant and vacancies may arise due to withdrawal. The counseling shall stop as and when the seats are filled up. Inconvenience regretted.

## **6. Eligible for participation in 2<sup>nd</sup> Round**

Candidates who have been registered but not been allotted a seat in 1<sup>st</sup> and 2<sup>nd</sup> Round of Counselling; (all candidates except those who are holding a seat of 1<sup>st</sup> and 2<sup>nd</sup> Round); withdrawn candidates subsequent to allotment in 2<sup>nd</sup> Round; allotted but not joined in their respective colleges after allotment in 2<sup>nd</sup> Round, shall be eligible to participate in the Mop-Up Round of Counselling.

In case of any grievance / representation, the decision of Admission Appellate Committee shall be final and binding on the candidates.

## **7. Notes**

(a) If the seats of sub-categories (i.e. Defence and PWD/PH) remain vacant, then they shall first be reverted to that respective parent category.

(b) Thereafter, the conversion of SC, ST, OBC to General Category shall be done only during the 2<sup>nd</sup> counselling. While converting the seats in 2<sup>nd</sup> round, any unfilled seat reserved for ST category will be offered to SC category and vice versa and only after completing this exercise, the conversion of the reserved category seats to General Category shall be effected. However, any OBC vacant seat shall be directly converted to General Category.

(c) All the candidates claiming seats in Defence Priority (I to VII) shall visit the University on the notified date and time. The University has already, on its website notified the list of P-1 to P-V who had got themselves verified within the notified dates and time.

(d) Candidates are requested to refer to the seats available for 2<sup>nd</sup> Counselling (as mentioned below). All the candidates have been called to ensure that no seat remain vacant. However, the counselling shall stop as and when the seats are filled up.

(e) Any category candidate, which have not been called and/or whose vacancy does not depict in the 'vacancy position' may attend the counselling as an unreserved category candidate and/or the vacancy may arise consequent to the conversion of categories during Mop Up counselling. **This is tentative vacancy position and may change. Final vacancy shall be displayed at the time of counselling.**

## **8. Fee to be paid at the time of Counselling**

(a) At the time of counselling / admission in the University, a candidate will mandatorily bring a demand draft of Rs.41,000/- (including Rs.1000/- (Non-Refundable Counselling Participation Fee) in the name of "Registrar, Guru Gobind Singh Indraprastha University", payable at Delhi.

(b) The candidates will pay the balance fee, in their respective allotted college

(c) The candidates shall be required to pay the revised fee, if such revision takes place.

**9. Since the Counselling falls on Wednesday, the 22<sup>nd</sup> August 2018 and the same may be declared as a Gazetted Holiday, all the candidates are advised to get their Demand Draft prepared and complete their documents well before the counselling date to avoid any inconvenience.**

All the candidates have been called to ensure that no seat remains vacant and vacancies may arisen due to withdrawal. The counseling shall stop as and when the seats are filled up. This is tentative vacancy position and may change. Final vacancy shall be displayed at the time of counselling.

10. The NEET qualified candidates who registered in GGSIPU (for admission in BDS programme in the affiliated dental college of Guru Gobind Singh Indraprastha University), shall report in person for Verification of Documents and Allotment of Seats, at the venue of counselling, on the date and time mentioned below, in the succeeding paras, as per their Category and Rank.


12. Important Note about the Horizontal Reservation of Defence and PH/PWD Category.

The seats in Defence Category and PH/PWD Category are reserved horizontally in all the categories such as GEN, SC, ST & OBC.

A candidate claiming a particular seat, shall be required to furnish all the valid certificates of those particular categories. E.g. a candidate claiming a seat in DOBCPH/PWD, must have been completed his 11<sup>th</sup> and 12<sup>th</sup> from Delhi, having a valid PH/PWD certificate and also possessing a valid OBC certificate. If some seats remain vacant in this sub-category shall first be reverted to the parent category in Second Counselling.
