Urgent Notification regarding filling up the Vacant Seats in Post Graduate Medical Courses (MD/MS/Diploma) in the affiliated medical colleges of Guru Gobind Singh Indraprastha University on 31st May 2018

1. In pursuance of the Order dated 30.05.2018 in Writ Petition No. 5971/2018, titled "Dr Rohan Kapoor and Co. Vs GGSIPU and Ors, from Hon'ble High Court of Delhi, Guru Gobind Singh Indraprastha University shall carry out a counselling for filling up the vacant seats in Post Graduate Medical Courses (MD/MS/Diploma) in the affiliated medical colleges of Guru Gobind Singh Indraprastha University.
2. Time and Date of Counselling - **04.00 PM onwards on 31.05.2018**
3. Venue for Counselling – Guru Gobind Singh Indraprastha University,
Sector 16C, Dwarka, New Delhi - 110078
(Nearest Metro Station : Sector 14 Dwarka)
4. The Vacant Seats shall be filled up based on the All India NEET PG 2018 Rank in merit only.
5. Registration for Counselling - 4.00 PM to 6.00 PM strictly
6. Seat Allotment of Registered Candidates - 6.30 PM onwards
7. **Vacant Seats.** Final vacancy position shall be displayed before the allotment. However, details of tentative / indicative seats are attached herewith for information. However, it is stated that "the vacant seat (not reported) of MS General Surgery – 01

seat – OBC Category of PGIMER, Dr RML Hospital, left out vacant after the mop-up round conducted by MCC/DGHS is reverted back to GGSIP University” vide notice dated 28.05.2018 on MCC website

8. Eligible for Counselling. As per the order dated 30.05.2018 in Writ Petition No. 5971/2018, titled “Dr Rohan Kapoor and Co. Vs GGSIPU and Ors, from Hon’ble High Court of Delhi in reference to Order of Hon’ble Supreme Court of India dated 25.05.2018 in the Writ Petition (C) No. 556/2018, titled “U.P. Unaided Medical Colleges Welfare Association Vs Union of India and Others, *“the candidate who has already secured admission elsewhere cannot be permitted to resign from the concerned college to avail the opportunity....”*. Hence, only those candidates who are not holding any seat at present (i.e. who have not been allotted any seat in any round of any counselling [State/All India/Deemed/Central Counselling etc]. Please note, the candidates who were allotted any seat, joined / joined and subsequently resigned even after paying the prescribed bond money, are not eligible for this round of counselling. All the candidates opting a seat in this counselling, have to give an undertaking to this effect.

9. Fees to be paid at the time of counselling: A candidate, who is allotted a seat, will be required to pay Rs. 28500/- (i.e. Rs. 27500/- and Rs. 1000/- NON-REFUNDABLE Counseling Participation Fee) on the spot, at the time of counseling . The fee will have to be paid in the form of Demand Draft in favor of “Registrar, Guru Gobind Singh Indraprastha University” payable at Delhi. In view of requests received due to bank strike on 31.05.2018, if the candidates like to submit the fee in CASH, the same shall be accepted as an exception. Balance fee, if any shall be paid, directly in the allotted college after admission

10. Joining in the allotted college. It is mandatory for the candidates who opt a seat in this counselling, to report in the allotted medical college on 31.05.2018 ONLY.

- (o) Passport size photographs – 4 nos.

12. Surety Bond. The student shall be giving a surety bond of Rs.3.0 Lakhs (Rs.25.0 Lakhs in case of opting a seat in PGIMSR-ESI) directly in their allotted college.

The stakeholders are requested to check the University website very frequently for updates please. The operating directions of the Hon'ble High Court of Delhi dated 30.05.2018 in the Writ Petition (C) No. 5971/2018, titled "Dr Rohan Kapoor and Co. Vs GGSIPU is reproduced below for information:

"Having considered the rival contentions of the parties I find merit in the contention of learned counsel for the petitioners that at this belated stage, the respondent no.1, cannot be allowed to offer the aforesaid four seats to candidates from the State quota by applying the institutional preference criteria, I am of the considered opinion that in view of the aforesaid order of the Supreme Court, it is incumbent upon the respondent no. 1 to offer all the 66 available seats to candidates only on the basis of their merit in the All India NEET Merit List.



Accordingly, it is directed that the respondent no. 1 will hold in counseling on 31st May, 2018 at 4:00 p.m. of all the eligible candidates desirous of taking admission against the aforesaid 66 seats on the basis of the "All India-NEET Merit List".

It is made clear that in case any further seats are made available, they will also be offered in the same counseling which is scheduled to be held tomorrow i.e. 31st May, 2018. However, it is made clear that any candidate, who has already taken admission in any other college, will not be permitted to take part in the counseling scheduled to be held tomorrow. The respondent no. 1 will be entitled to take declarations from the candidates in this regard at the time of counseling.
