Schedule for Common Counselling for admission in MD/MS/Diploma/ MDS/MD (Community Health Administration) /Diploma in Health Education held under the supervision of the Department of Health & Family Welfare, Govt of NCT of Delhi for admissions in Guru Gobind Singh Indraprastha University, University of Delhi and Hamdard Institute of Medical Sciences and Research (HIMSR) Jamia Hamdard – to be conducted by Guru Gobind Singh Indraprastha University

IMPORANT NOTE

Hamdard Institute of Medical Sciences and Research (HIMSR) Jamia Hamdard

Hamdard Institute of Medical Sciences and Research (HIMSR) Jamia Hamdard did not participate in the 1st Round of Counselling for admission which was held on 14th April and 15th April 2017. Counselling for admission in PG Seats in HIMSR Jamia Hamdard may be held during the 2nd Round of Counselling. A. '50% GGSIPU Quota Seats in MD/MS/Diploma' Seats

1. This has reference to the Schedule for Common Counselling (1st Round of Counselling) notified vide University's notification, No. GGSIPU/Admissions/2017/19911 dated 12/04/2017.
2. Only the seat allotment will be done during the 2nd Round of Counselling and no fresh registration for participation will be done. In no case, a candidate will be allowed to participate unless he/she had registered for participation before 1st Round of Counselling.
3. Seats available, to be filled during 2nd Round of Counselling, for the Academic Session 2016-18, for Post Graduate Medical Degree / Diploma Courses (PGMC) has already been notified on the University's website on 11/05/2017, titled "Vacancy position for 2nd Counselling of PGMC programme after considering withdrawals, remaining

seats of 1st counselling, AIQ reverted seats and vacancy arisen due to not joining within the stipulated date”

4. Admissions, during the 2nd Round of Counselling, shall be carried out in accordance with the procedure laid down in the Chapter 10, Part A, Admission Brochure 2017-18 (page 72 & 73).

5. Regarding ‘fees to be paid at the time of counselling’, candidates are required to please refer to Clause A. (ix) of the first counselling schedule.

6. For, ‘documents required at the time of counselling’, candidates are required to please refer to Clause A. (x) of the first counselling schedule.

7. The last date for joining the allotted candidates, in respect of the candidates taking admission / also those who shall change their college and/or specialization in 2nd Round of Counselling is 27th May as per the time lines stipulated by the Hon’ble Supreme Court of India.

8. **All the admissions are provisional. The candidates shall undergo biometric verification to be carried at the respective allotted medical colleges.**

9. Regarding OBC certificates, the date of the issue of non-creamy layer OBC certificate should be issued after 31st March 2017 as mentioned in the Admission Brochure.


10. Date and Time For Counselling :-

Phase 1. Vacancies arising on account of withdrawal and due to non-joining of the candidates within the stipulated dates, shall be filled in this phase. The seats shall be offered to the same category candidates merit rank-wise till all eligible candidates of that category are exhausted. Vacancies shown in Column (B) and Column (D) of the Vacancy Position notified on 11/05/2017.

Subsequently the resultant vacancies so created and the unfilled vacant seats of 1st round of counselling (Refer to the Column (A) of the Vacancy Position, shall be offered to the registered candidates who had not opted or allotted any seat during the 1st Round of Counselling and also, those registered candidates, who were absent during 1st Round of Counselling will also be eligible.

Phase 2. The resultant vacancies of Phase 1 shall be merged with the All India Quota reverted seats, as shown in Column (C) of the Vacancy Position and offered in the order of merit on the 200 point roster.

B. '50% University of Delhi MD/MS/Diploma and MDS / MD Community Health Administration / Diploma in Health Education' Seats'

1. University of Delhi has displayed the vacancy position including withdrawals, surrender and the AIQ reverted seats on their website on 11/05/2017. They have extended the date of surrender / relinquish the allotted PG seat of 1st counselling upto 4.00 PM on 13/05/2017. University of Delhi shall further display the vacancy position available for 2nd Round of Counselling on 15th May on their website and the procedure for carrying out admissions in 2nd counselling.



2. The detailed Schedule for 2nd Round of Counselling, shall be displayed by University of Delhi. However, the counselling shall be held on 17th May, 18th May and 19th May 2017 tentatively.

3. Only the seat allotment will be done during the 2nd Round of Counselling and no fresh registration for participation will be done. In no case, a candidate will be allowed to participate unless he/she had registered for participation before 1st Round of Counselling.

4. Regarding 'fees to be paid at the time of counselling', candidates are required to please refer to Clause B. (iv) of the first counselling schedule as referred above in this Schedule.

5. The last date for joining the allotted candidates, in respect of the candidates taking admission / also those who shall change their college and/or specialization in 2nd Round of Counselling is 27th May as per the time lines stipulated by the Hon'ble Supreme Court of India.

6. **All the admissions are provisional. The candidates shall undergo biometric verification to be carried at the respective allotted medical colleges.**


