## **OFFICE ORDER**

Various representations have been received from the students of BA LLB programme of Amity Law School, Delhi regarding promotion as stipulated in Clause 9.2 of Ordinance 11 of the University. Clause 9.2 of Ordinance 11 of the University states as follows:

"Student who has been detained due to shortage of attendance shall not be allowed to be promoted to the next academic year or semester and he/she will be required to take re-admission and repeat all courses of the said semester with the next batch of students. The University Enrolment number of such student shall however remain unchanged and he or she shall be required to complete the programme in a maximum permissible period as mentioned in clause 4.3".

In case of programmes covered by the Bar Council of India Rules / Regulations, in conformity with Rule 12 of the Rules of Legal Education – 2008 of the Bar Council of India and in consonance with other applicable provisions of Ordinance 11, it is clarified that the expression "has been detained due to shortage of attendance" in Clause 9.2 of Ordinance 11 of the University should be understood to mean and cover only such students who have not been allowed to take the end semester test in all the prescribed subjects of a semester because of the deficiency in the attendance. All such students who have been allowed to take the semester end examination in any one or more of the prescribed subjects of the semester shall not be covered by the said expression "has been detained due to shortage of attendance" in Clause 9.2 of Ordinance 11. Only such student who has not been allowed to take semester end examinations in all the prescribed subjects of a semester because of shortage of attendance shall be covered by the said expression "has been detained due to shortage of attendance"

Accordingly, all such students who have appeared in semester end examinations in one or more prescribed subjects of the semester and have acquired more than 50% credits as stipulated in Clause 11.3(v)(i) of Ordinance 11 shall be promoted to the higher academic year.

This issues with the prior approval of the Competent Authority.
