**Instructions for registration:**

1. No registration of team will be entertained post 5<sup>th</sup> October, 2017 11:59 PM.
2. Students can only register as team consisting of 3 members and no other format shall be entertained. The team composition will not be altered in this academic year.

5. The last date for submission of the soft copy of the memo shall be 24<sup>th</sup> October, 11:59 PM. ### **Moot Problem:**

Brilliant Cricket Academy (BCA) is a premier league in Kashmere Gate, Delhi having three bright cricket teams i.e. U-12, U-15 and U-20 under its umbrella. The season for cricket matches usually starts in the first week of August every year.

On 20<sup>th</sup> May, 2016, BCA enters into a contract with M/s Graham Sports Pvt. Ltd. (GSPL) having its Head Office at Mumbai for the purchase of 200 English Willows Bats (EWB) @ Rs.5000/- which were to be delivered by 10<sup>th</sup> July, 2016 at BCA's Office. BCA had paid the entire amount of 10 lacs in advance. One of the clauses of the agreement emphasized that the bats were to be delivered strictly well in time so that the teams could practice with the new bats atleast three weeks prior to the beginning of the season.

The manufacturing unit of GSPL was at Kolkata which after manufacturing and furnishing used to send the bats to the Head Office, Mumbai and then from there these were dispatched to the independent dealers. On 1<sup>st</sup> July, 2016, a fire broke out in the manufacturing plat of GSPL at Kolkata which destroyed atleast 40% of the stock of the bats lying there. The whole episode was duly covered and repeatedly telecasted by almost all 24 hrs. News Channels across the country.

On 8<sup>th</sup> July, 2016, 120 bats were delivered by GSPL to BCA with an assurance to supply remaining 80 bats as early as possible. BCA accepted the delivery of 120 bats.

On 12<sup>th</sup> July, 2016 BCA bought 80 bats from Allan Cricket Goods (ACG) @ Rs.7000/-. On 16<sup>th</sup> July, 2016 GSPL delivered the remaining 80 bats to BCA. On 1<sup>st</sup> August 2016 BCA filed a suit for damages and recovery of Rs.6,00,000/- (rupees six lacs only) in the Tis Hazari Court, Delhi accusing GSPL for breach of contract. The court decided in favour of BCA on 28<sup>th</sup> February, 2017.

GSPL files an appeal with High Court of Delhi

### **Rules for the preparation of the memorial:**

1. Each team participating in the Moot Court Competition must prepare Memorial from the side allotted to them after the draw of lots.
2. The memorial must contain the following parts:
  - i. Cover Page:

The cover page of the memorial must state the following:

    - a) Team Code on upper Right-hand side corner.
    - b) The Case Title
    - c) The name of the court
    - d) The year of the competition (the year during which the relevant round takes place).
    - e) Colour of the cover page must be
      - Blue in case of Petitioner/Appellant/Plaintiff.
      - Red in case of Defendant/ Respondent.
    - f) The Party for which the Memorial has been prepared.
  - ii. The Table of Content.
  - iii. The Index of Authorities.
  - iv. The Statement of Jurisdiction.
  - v. The Statement of Facts.
  - vi. The Statement of Issues.
  - vii. The Summary of Arguments.
  - viii. The Arguments Advanced.
  - ix. The Prayer
3. Memorial General Format:
  - i. Spacing: 1.5 Line Spacing
  - ii. Margins: One-inch margin on all sides of each page.
  - iii. Font: The font for the body of the memorial shall be Times New Roman, Size 12.
  - iv. The Font for the footnotes: The font of the footnotes shall be Times New Roman, Size 10.
  - v. Memorials must be spiral bound only.
  - vi. Page numbering should be at the bottom middle of each page.
  - vii. Teams shall cite authorities in their Memorials by way of Bluebook (19<sup>th</sup> ed.).

4. Length of the Memorial:

The total length of the pleadings, including the section headings, prayer for relief and any associated footnotes shall be no longer than 15 pages, and the whole memo shall be no longer than 25 pages.

5. The Memorials shall not, in anyway, disclose any fact pertaining to the identity of the Participating Team and its members.
