#### NOTICE

Hon'ble High Court of Delhi after hearing all the parties in the matter Yash Vardhan Vashisht vs. GGSIPU & Anr, W.P. (C) No. 12871, has issued notice to the respondent University and allowed interim relief sought by the petitioners to appear in the End Term Examinations November – December 2018 subject to the outcome of the above mentioned writ petition while clarifying that the said relief is granted because the students have actually undertaken courses with the Respondent No. 2 – Colleges / Institutes and further listed the matter alongwith other connected matter i.e. Somya Gupta & Ors vs. GGSIPU & Ors.

The Hon'ble High Court further observed that the following three issues mainly arise from the petitions:

- (i) **Issue of Inter University Migration**, in which the Petitioners who have applied for migration from their parent university to the Respondent No. 1 University and / or its affiliated colleges and their request for seeking migration have been rejected by the University.
- (ii) Second issue, where Petitioners who were given admission in Management Quota by the college however their provisional admissions were cancelled by the University in view of the fact that their result for the qualifying examination was not declared when they were given admission by the College.
- (iii) Third issue, where Petitioners are seeking change of Branch within the same institution.

Further, the Hon'ble High Court of Delhi, observing that there may be other students i.e. non-petitioners who are also similarly situated and have similar grievance and are not able to approach the Court due to any reason, directed the Respondent University No. 1 to permit those non-petitioners qua aforesaid three categories to appear in the End Term Examinations November – December 2018, subject to an undertaking in the format annexed to this notice (Annexure 1).

In pursuance of the interim relief and directions of the Hon'ble High Court of Delhi, it is informed that all the students who are similarly situated and have similar grievance as that of the petitioners in Yash Vardhan Vashisht vs. GGSIPU & Anr, W.P. (C) No. 12871 and Somya Gupta & Ors vs. GGSIPU & Ors, are permitted to appear in the End Term Examinations November – December 2018 at the examination centres allocated to the students who belong to the Respondent No. 2 – Colleges / Institutes and pursuing the programme that the petitioners as well as non-petitioners claimed to have actually undertaken the courses from.

The petitioner students and non-petitioners students falling in the category of petitioners students shall submit 02 copies of the Undertaking in the format as specified in the Annexure 1 and such students shall be allowed to appear in the End Term Examinations November – December 2018 by the respective Centre Superintendents.
