Reference aforesaid communication from the President, Ritnand Balved Education Foundation (RBEF) in respect of Amity School of Engineering & Technology (ASET), the following is decided:

- 1. For the Academic Session 2018-19, no admission will be carried out in ASET as notified earlier vide University Notice dated 12.06.2018 issued by Incharge (Admissions).
- 2. The request for disaffiliation of ASET made by the President RBEF shall be submitted to the Board of Affiliation, GGSIPU, for its consideration and decision in terms of Statute 24 of GGSIP University Act 1998, as communicated earlier vide letter dated 24.05.2018.
- 3. As regards, the students already admitted in ASET, prior to Academic Session 2018-19, the ASET shall continue imparting instructions and render other functions, responsibilities and duties of an affiliated institute till the Academic Session 2022-2023 or till the last among the admitted students passes out, whichever is earlier in terms of its obligation to continue imparting instructions to the admitted students read with the provisions of Ordinance 11 of the University.
- 4. Towards the process of closure/disaffiliation of ASET as requested by the President, RBEF, the RBEF and the Director, ASET should submit an affidavit in the proforma, as prescribed and annexed.
