



**Subject: Fee Structure to be charged by Self Financing Affiliated Institutes / Colleges affiliated with GGSIP University for fresh admissions for the Academic Year 2017-18 - reg.**

As per the Provision of the Delhi Professional Colleges or Institution (Prohibition of Capitation fee, Regulation of Admission, fixation of Non-Exploitative fee and other Measures to Ensure Equity and Excellence) Act, 2007 (Delhi Act 8 of 2007), the fee structure for the courses in Privately managed Institutions offering different courses, is to be notified by Govt. of NCT of Delhi for the Academic Session 2017-18.

The admissions for the academic session 2017-18 in various programmes in the University School/Affiliated colleges has already begun and as an interim measure, the fee structure as notified by the Govt of NCT of Delhi, in reference to notification F.No.DHE 4 68)/SFRC/14-15/1961-1974 dated 04.07.2016 and F.No. DHE 4 (68)/SFRC/14-15/1947-1960 dated 04.07.2016 issued by Directorate of Higher Education, Govt of NCT of Delhi, the fees as payable by the students admitted in the first year in a programme in the respective Institute/College for the Academic year 2016-17 and as the circular of fees to be charged issued by the University is enclosed herewith for the fees meanwhile as payable by the Students admitted in the first year in a Programme in the academic session 2017-18 till any other notification is issued by Govt of NCT of Delhi, in the matter of fee to be charged for Academic Session 2017-18. The notification issued by Govt of NCT of Delhi in the matter of fee to be charged for students admitted in the first year of the programme for the Academic Session 2017-18 will be binding to all students admitted in 2017-18.


In reference to notification F.No.DHE 4 (68)SFRC/14-15/1961-1974 dated 04.07.2016 and F.No. DHE 4(68)SFRC/14-15/1947-1960 dated 04.07.2016 issued by the Directorate of Higher Education, Govt of NCT of Delhi, the fee as payable by the students admitted in the first year in a programme in the respective Institute / College for the Academic year 2016-17 is enclosed herewith.

As some of the existing affiliated Institutes / Colleges have also been approved for new programme(s) in Academic session 2016-17 and some new Institutes/colleges with programmes have also been affiliated in Academic session 2016-17. Such Institutes / Colleges are to approach to State Fee Regulatory Committee (SFRC) for finalization of the fee accordingly, meanwhile purely as an interim measure, the University has approved for interim fee structure for such Institute / Colleges to be taken for the fresh admission in the first year, for the Academic year 2016-17. For the students being admitted in the programme in such respective Institute / College, the final fee is subject to finalization / notification of the fee structure by Govt of NCT of Delhi on recommendation of SFRC. All such students freshly admitted in 2016-17 in such Institutes / Colleges, shall undertake to abide by any such fee notification issued by Govt of NCT of Delhi at any later stage and will pay the balance fee / any dues etc., as notified in due course by Govt of NCT of Delhi.

In addition to above as stated, the University charges of Rs. 12,000/- (For students admitted in Academic Session 2016-17), security amount (one time) of Rs. 5000/- and Student Activity fee of Rs. 1000/- per annum shall be charged from the student. The Security amount one time is Refundable from the respective College / Institute.

All concerned Institutions / Colleges affiliated with GGSIP University must inform the admitted students in the Academic Session 2016-17 about the fee structure mentioned as above and no other fees other than notified is to be obtained from the students.


