## **Notice with respect to orders of the Hon'ble High Court of Delhi dated 22.11.2018/23.11.2018 in respect (a) Inter University Migration, (b) Management Quota Admissions and (c) Shift with Stream Change**

Various petitions were filed in the Hon'ble High Court of Delhi impugning decisions of the University, in respect to for the following and seeking relief thereto:

- (a) Inter University Migration (Lead petition W.P. (C) 12097/2018 and other associated/related petitions)
- (b) Management Quota Admissions (Lead petition W.P. (C) No. 11903/2018 and other associated/related petitions)
- (c) Change of Shift and/or Stream / Discipline Change (Lead petition W.P. (C) No. 12219/2018 and other associated/related petitions including Raghav Anand & Ors vs. GGSIPU & Anr)

In respect to these cases, the Hon'ble Court was pleased to grant interim relief to the petitioners as follows:

- (a) **Inter University Migration**: All petitioners are allowed to sit for examinations of Nov./Dec., 2018 as an interim relief. The Hon'ble Court has further clarified that the interim relief to sit in the examination is subject to the outcome of the writ petitions.
- (b) **Management Quota Admissions**: All petitioners are allowed to appear in examinations of Nov./Dec., 2018 as an interim relief. The Hon'ble Court has further clarified that the interim relief to sit in the examination is subject to the outcome of the writ petitions.
- (c) **Change of Shift and/or Stream / Discipline Change**: Those petitioners that are asking for shift as well as stream change are allowed to appear in examinations of Nov./Dec., 2018 as an interim relief. The Hon'ble Court has further clarified that the interim relief to sit in the examination is subject to the outcome of the writ petitions.

It is clarified that, petitioners who are/were **only** requesting for change of shift, without any change of stream / discipline of study, the Hon'ble Court has observed that there is no urgency warranting intervention by the Hon'ble Court. Therefore, these petitioners may appear in the end term semester examinations Nov./Dec., 2018.

The Hon'ble High Court in its Order dated 22.11.2018/23.11.2018 as an interim measure has allowed these petitioners to sit in the forthcoming Examinations (November 2018) of the University (as per details stated above).

**It is reiterated that in the directions/orders stated above, the Hon'ble Court has clarified that the interim relief to sit in the examination is subject to the outcome of the writ petitions.**

All these above stated petitioners are hereby advised to report to the Admission Branch, Administrative Block, Guru Gobind Singh Indraprastha University, Sector 16C, Dwarka, New Delhi 110075 on 26/11/2018(Monday) at 2.00 P.M. to complete the requisite formalities.
