## OFFICE ORDER

Whereas a complaint dated 24<sup>th</sup> April, 2017 has been received by the University wherein it is alleged that Dr. Dinesh Yadav, Consultant Paediatrician, PGIMER, Dr. Ram Manohar Lohia Hospital, New Delhi which is affiliated to Guru Gobind Singh Indraprastha University had violated mandatory procedures for conduct of drug trial viz. Registration with Central Trial Registry of India (CTRI) and Approval of Institutional Ethics Committee, the findings of which were presented in the 6<sup>th</sup> World Conference of Pediatric Cardiology held on 17<sup>th</sup> – 22<sup>nd</sup> February 2013 at South Africa under the title "**Randomized Control Trial of Intravenous Immunoglobulin in Acute Thyocarditis in Pediatric Age Group**" showing Dr. Dinesh Kumar Yadav as first author.

And whereas the University, keeping in view the grave nature of allegations, and the likely adverse impact on public interest, if allegations are proved to be correct, sought a report from the PGIMER, Dr. Ram Manohar Lohia Hospital, New Delhi vide letter dated 4<sup>th</sup> July, 2017.

And whereas in response to the letter dated 4<sup>th</sup> July, 2017, the University has received a copies of the report sent by PGIMER & Dr. RML Hospital, New Delhi to the Ministry of Health & Family Welfare, Govt. of India vide letter dated 02.05.2017 and supplementary report sent vide dated 25.08.2017, which categorically concludes as follows:

***"While going through the report, it is evident that Dr. Dinesh Kumar Yadav, has violated Medical Ethics and continued the research inspite of instructions from Institutional Ethics Committee (IEC) of PGIMER & Dr. RML Hospital to comply the required condition to issue ethical clearance. It is quite clear that he has done the research work avoiding the instructions given by Ethics Committee which reflects his integrity is doubtful. There was no formal approval for such work even from then HoD, Paediatrics, Dr. RML Hospital."***


***The supplementary report even pointed out that the data shows there have been two deaths and Dr. Dinesh Kumar Yadav was the Principal Investigator (PI) since he submitted the trial project to IEC as PI.***

Keeping in view the reports received from PGIMER, Dr. RML Hospital, New Delhi, a Committee was constituted by competent authority, Guru Gobind Singh Indraprastha University, Delhi and the recommendations of the Committee duly approved by the competent authority are hereby conveyed to all the concerned for implementation and necessary action. However, the decision of the University in this matter does not in anyway affect any appropriate action that the controlling authority of Dr. Dinesh Kumar Yadav, may like to take as per the rules.
