




No.F.2(37)/Ord/IPU/JRP/2010/ :- In partial modification of Notification dated 10th March 2005 and in pursuance of the provisions of Section 27 of the Guru Gobind Singh Indraprastha University Act, 1998 (9 of 1998), the Board of Management of Guru Gobind Singh Indraprastha University, hereby makes the following partial amendment in Clause 8 1(a) of Ordinance 8 regarding Appointment of Qualified Staff / Recognition of Teachers in pursuance of Statute 18.

As the minimum qualifications and experience laid down for teaching posts for various disciplines/programmes are being amended by the Statutory Bodies, e.g. (UGC)/AICTE/NCTE/ etc. from time to time and the same has not been amended/incorporated in the relevant clause of Ordinance 8, therefore, it is proposed to repeal the existing clause 1 (a) (i) regarding qualification and experience as laid down for various programme as specified in the appendices linked herewith, in the existing Ordinance 8 and replace the same with the amended clause in regard to the minimum qualifications and experience as laid down for teaching posts for various disciplines/programmes (Appendix A to Appendix M) for teachers of the Colleges or Institutions affiliated to the University, which are in force from time to time for the discipline/programme under the concerned Statutory Bodies e.g. UGC/AICTE/NCTE/ etc.
