**Sub: Invitation of Expression of Interest (EOI) for providing hospitality and catering services during the University's Annual Cultural Festival 'Anugoonj 2012'**


The Guru Gobind Singh Indraprastha University is going to organize '13<sup>th</sup> Annual Cultural Festival 'Anugoonj 2012' to be held from 2<sup>nd</sup> to 4<sup>th</sup> Feb 2012 on its campus at Sector-16C, Dwarka, New Delhi. Anugoonj is one of the largest and the best University festival in Delhi. Around 60,000 students from more than 110 affiliated colleges of the University will participate/ visit during the festival.

The University invites Expression of Interest (EOI) from the reputed firms/ caterers for providing hospitality and catering services during the Annual Cultural Festival 'Anugoonj 2012'. The University will provide around 20 food stalls of the area of 15'x15' with electricity to the firms/ caterers on rent basis. The base rent of food stalls would be Rs.25,000/- per stall for the period of festival. The firms/ caterers may sale only 05 food items/ snacks/ beverages (only Pepsi/ Tea/ Coffee) from one food stall.

Interested firms/ companies may submit their Expression of Interest (EOI) for taking food stalls to sale food/snacks/ beverages to the Faculty/ Staff/ Students of this University during the 'Anugoonj 2012' in a sealed envelope alongwith the price of each item of each stall and the amount of the food coupons offered to the University. Their proposals should be submitted in a sealed envelope addressed to Prof. Anup Singh Beniwal, Director Students' Welfare, Guru Gobind Singh Indraprastha University, Sector-16C, Dwarka, New Delhi - 110 075 before 11:00 a.m. on 18<sup>th</sup> January 2012. The EOI/ proposals submitted by the firms will be opened on the same day i.e. 18<sup>th</sup> January 2012 at 3:00 p.m. in the office of Director, Students Welfare.

**Terms & Condition**

1. Outsourcing/subletting will not be allowed.
2. The eatables should be clean and hygienic.
3. Food stalls of the area of 15'x15' with electricity will be provided by the University.
4. The base rent of food stalls would be Rs.25,000/- per stall payable within 03 days from the date of issue of food stall allotment letter.
5. The base rent should be deposited in the form of Demand Draft favouring Registrar, Guru Gobind Singh Indraprastha University, payable at Delhi.
6. Caterers can quote for any food items/ snacks/ beverages (only Pepsi/ Tea/Coffee) of their choice.
7. Rates of food items/ snacks/ beverages will be finally decided by the University.
8. The University reserves the right to allot all food stalls to one or more than one firms/ companies.
9. The University reserves the right to accept or reject any application without assigning any reason there for.
10. The University reserves the right to withdraw the given contract anytime without assigning any reason.
