- 1. B.E/B.Tech/Post Graduation in Fire/Fire Safety/Industrial Safety/Life Safety/other related field with minimum 50% Marks.**
- Or**
- 2. Bachelor's/Post Graduation Degree in any field with minimum 50% marks and having minimum relevant working experience of 2 years.**

Note:

The Final Counselling shall be the last opportunity for eligible candidates to participate in the admission process. Candidates are advised to report on the scheduled date and time. No further opportunity for counselling shall be provided thereafter.

* Allotment on the horizontal Sub-Category seats shall be carried out as per the guide lines given in the following paras.

* Please note that, if there are no seats in any sub-categories viz DST-PH, DST-DEF, ODSC-PH, ODSC-DEF, ODST-PH and ODST-DEF, they may claim seat in UR/ other respective category in their respective region.

* The candidates claiming seats in any sub category shall have to produce the valid certificate for for claiming the seat e.g. a candidate claiming a seat belonging to SC-DEF shall have to produce valid certificate for SC category as well as Defense Category

Important:

- A candidate belonging to any sub-category is also eligible to secure admission in General / Unreserved Category of his/her respective Region, purely on the merit of CET.
- The Defence and PWD reservation shall be in all categories in a horizontal manner. If the seats of these sub-categories (i.e. UR-DEF, SC-DEF, ST-DEF, UR-PWD, SC-PWD & ST-PWD remain vacant, they shall be reverted to the parent category first during the Counselling.
- The conversion of seats reserved for SC, ST to General Category shall be done only after the completion of counseling for the reserved categories.
- There shall be no reserved seats for OBC category candidates for Post Graduation/Master Level Programme; hence, they shall be eligible for allotment of seat in UR/GEN category or any other applicable sub-category of the candidate.
- Allotment of Seats will stop as and when the seats get filled up.

- Work Experience Certificate in the relevant field, applicable only to candidates seeking admission under the eligibility criterion of a Bachelor 's degree any field with the prescribed two years of relevant work experience, as specified in the admission brochure 2026-27.

- The candidate will be required to bring the Original certificates/Mark-sheets of all the year wise or semester wise in original along with photocopy of Certificates/ Mark-sheets of qualifying examination.

In case of students who have passed the qualifying examination through distance / open education system of any recognized University / Board / Institution, the necessary documentary evidence related to location of his / her study centre i.e. study centre proof, certificate from the University imparting open / distance education certifying the location of the study centre to be submitted.

j) **Physical Fitness Certificate:**

All the students shall be required to submit a Medical Certificate indicating fitness from a Registered Medical Practitioner as per format given in Performa of Medical Certificate in given in Part-F in Admission Brochure 2026-27 (As per Appendix 5).

k) **Reserved Category Certificate in addition to Appendix 10:**

The candidates seeking admission under reserved categories, must have to mandatorily bring the entitled supporting certificate in his/her name. The Candidates for further details must read Chapter 6 (Reservation Policy) of respective Admission Brochure 2026-27.

In case the candidate is claiming the seat reserved for DSC/DST category then He/ She should have passed his/ her qualifying exam from Delhi School/College and must have SC/ST certificate issued by the Competent Authority of Govt. of NCT of Delhi only.

For claiming reservation on a seat reserved for **Defense Category**, the candidate must have to bring the duly filled and signed **Appendix 1** of Admission Brochure 2026-27 by the competent authority as mentioned in Admission Brochure 2026-2027.

Reserved Category Candidates who fail either to bring documents as per notified schedule or whose documents are not in order **will forfeit his/her right for the reserved category claimed** and will automatically be converted to General Category as per University rules.

All reservation category candidates who are seeking admission in reserved category in SC/ ST/DEF/PWD/KM must bring their reservation certificate (the caste/category certificate should invariably be in the name of candidate himself/herself and not in favour of respective parents/ guardians) in original along with the self attested photocopy of the certificate for claiming seat against the reserved category.

- l) Conduct and Character Certificate in original from the Head of the Institution from where the qualifying examination has been passed or from Gazetted officer in Original, not more than 06 (six) months old.
- m) The required Certificate(s) for reserved categories / classes will be essential at the time of the counselling / admission and no provisional admission shall be admissible for want of caste/category certificate from the local competent authority. Further, the caste / category certificate should invariably be in the name of the candidate himself / herself and not in favour of respective parents / guardians.

2. It will also be the sole responsibility of the candidates themselves to make sure that they are eligible and fulfill all the conditions prescribed for admission. Before filling-up the verification slip at the time of verification of documents/counselling/allotment of seats, candidate should ensure that he/she fulfills all eligibility conditions as laid down in the respective Admission Brochure for the session 2026-27.
