Subject: Guidelines for obtaining Eligibility Certificate by Persons with Benchmark Disabilities (PwBD) candidates for admission to MBBS Course – UG Counselling 2026

This is for the information of all concerned PwBD candidates participating in UG Counselling 2026 for admission to the MBBS Course that the NMC has issued guidelines regarding the assessment of PwBD for admission to MBBS Course, 2026.

As per the directions issued by the Medical Counselling Committee (MCC), Directorate General of Health Services, Government of India, candidates intending to claim a seat under the **PwBD category** are required to obtain an Eligibility Certificate from the designated Medical Assessment Boards of MCC. PwBD candidates are advised to note the following:

1. Candidates claiming a seat under the PwBD category are required to visit any one of the designated Medical Assessment Boards of MCC and submit the prescribed documents for obtaining the Eligibility Certificate.
2. The following documents are required:
 - NEET UG 2026 Score Card demonstrating eligibility for the MBBS Course;
 - Permanent UDID Card issued by the Department of Empowerment of Persons with Disabilities (Divyangjan), Ministry of Social Justice and Empowerment, Government of India;
 - Self-certified affidavit declaring functional abilities in the prescribed format;
 - Self-Certification Affidavit and disability-specific affidavit in the prescribed NMC format.
3. The Eligibility Certificate shall be generated by the concerned Medical Assessment Board based on the disability details mentioned in the UDID Card and the affidavit submitted by the candidate, subject to fulfilment of the prescribed eligibility criteria.
4. Only candidates who have obtained an Eligibility Certificate from a designated centre of MCC shall be considered for choice filling of PwBD seats.
5. The Eligibility Certificate shall be valid only for the academic session concerned.
6. Candidates seeking to avail PwBD seats under the 85% State Quota may approach the designated State Medical Assessment Boards for obtaining the required certificate. The assessment shall be conducted in accordance with the NMC Guidelines, 2026.
7. In case the UDID Card or affidavit submitted by a candidate is found to be fake, the candidature/seat of the candidate shall be cancelled and appropriate legal action may be initiated as per rules.

All concerned candidates are advised to carefully read the MCC Notice Ref. U-11011/07/2026-MEC dated 30.07.2026 and the NMC Guidelines on Assessment of Persons with Benchmark Disabilities (PwBD) for Admission to the MBBS Course, 2026, before participating in the counselling process.
