CUET Qualified Candidates:

Any candidate who had registered earlier but due to any reason not deposited the registration fee of Rs. 2500/- and is interested in getting admitted to **M. Sc. (EM)** may also report on **25.09.2026 (Friday) from 09.30 a.m. onwards**. Such candidates are required to pay the **Registration Fee i.e. 2500/- (Rupees Two Thousand Five Hundred Only) (Non Refundable)** through a bank draft in favour of Registrar, Guru Gobind Singh Indraprastha University or through online mode on the spot.

Graduate Candidates (Who could not attend in any entrance Test):

Any candidate who wish to seek admission to **M. Sc. (EM)** may also report on **25.09.2026 (Friday) from 11.30 a.m. onwards**. Such candidates are required to pay the **Registration Fee i.e. 2500/- (Rupees Two Thousand Five Hundred Only) (Non Refundable)** through a bank draft in favour of Registrar, Guru Gobind Singh Indraprastha University or through online mode on the spot. The allotment of seat will be offered after verification of documents and on the basis of merit of candidates, who will be present on the same day.

Important:

1. Eligibility Criteria for Programme-

Master of Science (Environment Management) CET Code 111: Graduation in Sciences/ Engineering/B.Voc in Science Stream (10+2 in science is mandatory). Degree with atleast 50% marks in aggregate.

2. Offline Counseling Procedure

Candidates shall please refer to the Chapter 8: 'Offline Counseling Procedure', Admission Brochure for PG Programmes 2026-27.

3. Fee (Refer Admission Brochure page 164)

Bank Draft(s) of Rs. 1,32,300/- (One Lac Thirty Two Thousand Three Hundred) only in favour of **Registrar, Guru Gobind Singh Indraprastha University**, payable at Delhi. The candidate must write his/ her name, date of admission, phone number, address, mobile number, name of the programme, CET/ CUET Rank, and CET/ CUET Roll Number on the back of the Bank Draft(s). The students can also submit the fee via online mode on the following link:

4. Candidates who had opted for M. Sc.(EM) but could not complete the registration process may also be permitted to take admission during the counseling on the basis of a valid CUET score by paying fee of Rs. 2500/-.

Documents Required for Verification and Allotment of Seats (alongwith a set of photocopies):

- a) Four passport sized photographs
- b) PG CET/ CUET Rank Card/Merit Order of PG CET/ CUET 2026 (copy)
- c) PG CET/ CUET 2026 Admit Card (in original).
- d) Filled Admission verification form as per Appendix 5 of Part F of Admission Brochure 2026-27.
- e) Filled Preference sheet as per Appendix 10 of Part F of Admission Brochure 2026-27.
- f) Proof of date of birth (Secondary School Mark-sheet & Certificate) (Original and Photocopy)
- g) Mark-sheets / Certificates of qualifying examination:
The candidate will be required to bring the Original certificates/Mark-sheets of all the year wise or semester wise in original along with photocopy of Certificates/ Mark-sheets of qualifying examination.
- h) For Distance / Open Learning Cases:
In case of students who have passed the qualifying examination through distance / open education system of any recognized University / Board / Institution, the necessary documentary evidence related to location of his / her study centre i.e. study centre proof, certificate from the University imparting open / distance education certifying the location of the study centre to be submitted.

- i) Physical Fitness Certificate:
All the students shall be required to submit a Medical Certificate indicating fitness from a Registered Medical Practitioner as per format given in Performa of Medical Certificate in given in Part-F in Admission Brochure 2026-27 (As per Appendix 4).
 - j) Result Awaited: candidates seeking admission as result awaited candidate must have to submit Appendix 3 of Part F of Admission Brochure 2026-2027.
 - k) Conduct and Character Certificate in original from the Head of the Institution from where the qualifying examination has been passed or from Gazetted officer in Original, not more than 06 (six) months old.
 - l) Application regarding age relaxation with necessary approval, if any, shall be submitted on or before **25.09.2026**.
5. It will also be the sole responsibility of the candidates themselves to make sure that they are eligible and fulfill all the conditions prescribed for admission. Before filling-up the verification slip at the time of verification of documents/counseling/allotment of seats, candidate should ensure that he/she fulfils all eligibility conditions as laid down in the respective Admission Brochure for the session 2026-27. If it is found at any stage during the entire period of the programme that the candidate does not fulfill the requisite eligibility conditions, his/her admission will be cancelled and also disciplinary action will be initiated against his/her and entire fee will also be forfeited.

As per University/ UGC Guidelines mentioned in the Admission Brochure.

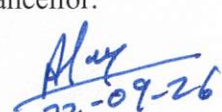
