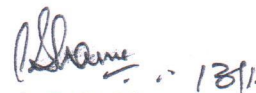

Awareness workshops be conducted by the colleges for promoting integrity and prevent plagiarism. Institutes should warn the stakeholders about penal action in case of detection of plagiarism.
